#### Academic Audit Report

### 1. SSS obtained from Students Feedback (2019-20)

The feedback was collected from 184 students about Academic audit which was analyzed, verified and found that in the session 2019-20

- The official website was accessible to 78.25% of students and 21.75% did not access.
- 80.97% of students were benefitted by academic counseling and 19.03% were not benefitted.
- 83.70% students were satisfied by teaching leaning facility of the college and 16.30% were not satisfied.
- According to 80.43% students, teachers were able to complete the curriculum within the scheduled period and the response of 19.57% students was negative.
- According to 77.17% of students of students the central and departmental library of the college were well equipped to cover the course content and 22.83% answered negatively.
- 71.75% of students were benefitted by the tutorial and digital classes and 28.25% were not benefited.
- 75% of students were satisfied with the provision of two internal assessment conducted by the examination authority and 25% were not satisfied.
- According to 81.52% students, teachers suggested study materials and the response of to 18.48% was negative.
- According to 80.97% students, organized seminars/group Discussion was organized in the college and 19.03% was not attended in these programs.
- 73.37% of students they were benefitted by extension activities/career counseling organized by IQAC in the college and the response of 26.63% expressed was negatively.

### 2. SSS Obtained from Students' Feedback Report :On Curriculum, 2019-20


Student's feedback on curriculum was collected from 220 students in the session 2019-20 and verified by the committee. It is found from the analysis that -

- When the question regarding the curriculum was sufficient to give adequate knowledge asked, 41.36% students strongly agreed, 5.45% agreed, 6.36% did not agreed and 1.83% did not response.
- Where the prescribed textbook/reference books sufficient for understanding of the students on that question they responded as followers: 42.27% strongly agreed, 43.18% agreed, 10.91% do not agree and 3.64% did not response.
- When they were asked whether the curriculum provides scope in terms of subject choice they responded as follows: 36.81% strongly agreed 43.64% agreed, 15% did not agree and 4.55% did not response.
- Regarding the question, whether curriculum is relevant according to the present day situation students responded as follows: 40.45% strongly agreed, 50.91 agreed, 6.36% do not agree and 2.28% students did not response.
- When students were asked that whether the curriculum provide scope for present day employment them to pursue higher studies students, they responded as followers: 41.36% strongly agreed, 45% agreed, 7.73% did not agree, 5.91% did not response.
- When students were asked whether curriculum helps to pursue higher studies they responded as follows: 35.91% strongly agreed, 43.18% agreed, 12.27% did not agree, and 8.64% did not response.


