<u>SYNOPSIS</u>

In pursuance of an advertisement dated 19.2.2016 issued by the Principal of Tangla College, Tangla for the post of Finance/Banking, the petitioner being eligible for the said post having Master Degree in Commerce as well as NET qualification two times, applied for the same. The authority of Tangla College had issued admit card against which the petitioner appeared in the interview held on 12.1.2017 and done well in the interview with a hope that he will be selected for the said post. But when no result has been published the father of the petitioner namely Tarun Swargowari submitted an application dated 24.6.2017 under RTI Act, 2005 seeking information regarding result of the said interview dated 12.1.2017. The petitioner also approached the College authority several times regarding outcome/result of the said interview, but the College authority failed to give any satisfactory reply to him.

Inspite of the aforesaid position in as much as without declaring the result of earlier selection process the Tangla College authority has issued the impugned/second advertisement dated 21.8.2019 for the same post for which earlier advertisement was held on 12.1.2017 that without publishing the result of the same. Which deprived the petitioner from his legitimate expectation of being appointed.

Hence this writ petition.



That pursuant to the advertisement dated 19.2.2016 issued by the office of Principal of Tangla College, Tangla i.e. respondent No. in the local daily "Assam Tribune", inviting application from eligible candidates having UGC norms for filling up of post of Assistant Professor in various departments including one of post of Banking/Finance (unreserved). Accordingly petitioner having requisite qualification has applied in the prescribed form with the requisite documents/testimonials. Accordingly the authority of Tangla College has issued Admit Card and asked to appear before Interview Board through Call letter dated 28.12.2016, which was held on 12.1.2017.

Copy of the Advertisement dated 19.2.2016 published in "Assam Tribune" and Admit Card dated 28.12.2016 are annexed herewith and marked as Annexure-C & D respectively.

4. That since no reply has been received against application dated 17.1.2017, his father namely Tarun Swargowari again submitted an application dated 24.6.2017 under RTI Act, 2005 seeking some information from the authority of Tangla College including the result of interview dated 12.1.17 held at Tangla College for the post of Assistant Professor, Finance Department of Commerce. But till date the authority of Tangla College has not given any reply to the aforesaid application dated 24.6.2017.

A copy of the application and RTI application dated 17.1.2017 and 24.6.2017 are annexed herewith and marked as Annexure-E & F respectively.

5. That while the petitioner was awaiting for result of the earlier selection in the Department of Finance, Tangla College. Second advertisement dated 21.8.19 was published by the Principal of Tangla College inviting application for various posts including in the post of Assistant Professor of Finance Department of Commerce at Tangla College mentioning the same to be reserved for candidates, without declaring the result of first interview held on 12.1.2017. The said second advertisement dated 21.8.19 has been impugned in this Writ Petition. Immediately petitioner filed a representation before the respondent authority to enquire about the status of the result of the first advertisement.

A copy of the impugned advertisement dated 21.8.2019 and representation dated 28.8.19 are annexed herewith and marked as Annexure-G & H respectively.

Inputed Annexure 4-25-26

That the petitioner begs to state that he belongs to Schedule Tribe Community. He had a brilliant academic carrier and as such after passing M.Com examination with major in Finance subject in the year 2014, as well as NET qualifications. He applied for the post of Assistant Professor in reference to the advertisement dated 17.2.2016 and accordingly through Call letter he appeared for the interview held on 12.1.2017.Petitioner was with a great hope and expectation waiting for the result, but unfortunately results has not been declared till date.

Such act on the part of the respondent authorities are discriminatory and unfair land same amounts to violation of the right of the petitioner.

- 7. That the petitioner respectfully submits that under the facts and circumstances stated herein above, the interference of this Hon'ble Court is very much necessary. Otherwise petitioner will remain deprived from his legitimate right. Therefore, the petitioner has approached this Hon'ble Court under compelling circumstances seeking justice and remedial measures which was denied to him.
- 8. That there is no any other alternative, efficacious and speedy remedy then to approach before the Hon'ble Court and the remedy sought for would be just and proper if granted.
- 9. That the petitioner begs to state and submit that the petitioner demanded justice and the same have been denied to him.
- 10. That this petition is made bonafide and in the interest of justice.

In the premises aforesaid, it is therefore prayed that Your Lordships may be pleased to admit this writ petition, call for the records and issue a Rule calling upon the respondents to show cause as to why:-

(A). A writ in the nature of Certiorari should not be issued, setting aside/quashing the impugned advertisement dated 21.8.2019 issued by the Principal of Tangla College, Tangla. (Annexure-E).

(B). A writ in the nature of mandamus should not be issued directing/commanding the respondents not to give effect of the said impugned advertisement dated 21.8.2019 and/or on cause or causes being shown upon hearing the parties and on perusal of records be pleased to make the rule absolute and/or pass such other or orders as Your Lordships may deem fit and proper.

-AND-

Pending disposal of the Rule, Your Lordship may be pleased to stay operation of the impugned advertisement dated 21.8.2019 issued by the Principal of Tangla College, Tangla, for the ends of justice. (Annexure-E).

And for this act of kindness, your petitioner as in duty bound shall ever pray.
