In the said notification it was also stated that the candidates must have permanent residential certificate and must know the local languages. It is also stated that the preference would be given to the candidates who are the residents of BTC area subject to the fulfilment of all criteria. After getting that information regarding the advertisement under the caption "SITUATION VACANT" she get relaxed that finally she could able to apply for the Assamese post of Assistant Professor as she fulfil the eligibility criteria for the post. As per Annexure No.5A document petitioner is entitled to get preferential treatment for the post of Assistant Professor of Assamese Subject.

That thereafter the petitioner applied for the post 7. of Assistant Professor of Assamese (B -Group) annexing all the required documents within the stipulated period of time and after a long period the respondent No.6 issued an Interview Call letter dated 18/05/2022 whereby the petitioner was directed to appear before the penal of exparts/interview Board on 2/6/22 form 10.00 A.M. onwards. In the said interview call letter no venue was mentioned. However the petitioner metthe Principal of the College on the fixed date the said that penal of time and Principal exparts/interview Board would conduct the interview at the College itself, and accordingly the petitioner appeared before the penal exparts/interview Board and she was interviewed by the same authority where she performed well and expecting for appointment for the said post.




